Go to the main content act now to make sure your home is safe. If you have a chest/chest dresser that is listed in the June 2016 recall or the KULLEN-3 recall, there are several ways you can participate in these recalls. Return the chest/chest of drawer to a store If you do not want to fix the product to the wall, you can return your chest/chest to the store for a refund. Ask for a recording/refund of your chest/chest of drawers If you don't want to fix your chest/chest of drawers to the wall and would rather not give back your chest/chest of drawers to the store yourself, contact us and see what comes to your house, pick up your chest/chest of drawers and you'll get a refund free of charge. Ask for a free wall mounting kit. If you would like to ask for a kit to fix your chest or chest of drawers to the wall and want to fix it yourself, please ask for a wall anchor kit or reference the wall anchoring guide below. Wall Anchoring Guide (PDF) Request chest/chest of drawer fixing If you want to fix your chest/chest of drawers on the wall, but would rather not do this yourself, contact us and we will send someone to your home to secure your chest/chest of drawers for you free. The recalled KULLEN 3 chests were manufactured and sold between 2005 and 2019. For the label below, you can check the product label inside the top or side frame of the device to see if your chest is included in the recall. IKEA crates covered by the June 2016 recall and were manufactured and sold on dressers until June 2016. To determine if your device is being recalled, please see the full list below. Never place a TV or other heavy objects on furniture that is not intended for use with a TV. Never let children climb up or hang on drawers, doors or shelves. How do I tell if my IKEA chest or wardrobe is covered by this recall? The KULLEN 3-drawer chest recall affects the KULLEN 3 chest of drawers. The chest is 28 3/8 inches tall, sold in black-brown or birch wood color. The recalled KULLEN 3 crates were manufactured and sold between April 2005 and December 2019. KULLEN 3 chest of drawers has article numbers 600-930-58 (birch), 501-637-54 (black-brown) and 803-221-34 (black and brown). At the bottom of the top panel or on the side panel there is a 5-digit vendor number, a 4-digit date stamp, ikea logo, country of origin and KULLEN. If you have any questions about whether your chest or locker is included in the recall, you can contact Contact IKEA by email secureit@ikea.com call IKEA toll-free at (888) 966 4532. The June 2016 recall will cover all IKEA children's crates and higher than 23.5 inches and adult crates and cabinets taller than 29.5 inches that do not meet the performance requirements of the U.S. Voluntary Industry Standard (ASTM F2057-014). The recalled crates and dressers were manufactured or sold until June 2016. Recalled crates and cabinets include MALM 3-drawer, 4-drawer, 5-drawer and 6-drawer cabinets, as well as other models listed www.IKEA-USA.com/saferhomestogether on ikea's website. Since 1996, IKEA crates and dressers have been identified by IKEA, model name and production date code. Units manufactured before June 2016 have a date code lower than 1.622. The free wall anchor repair kit comes with the necessary hardware and clear instructions, so you can properly attach the chest or cabinet to the wall. After the recall, I bought an IKEA chest or dresser for the recall from someone other than IKEA. Can I participate in the recall? If you have a chest or chest of drawers, you can participate in the relevant recall and get: (a) a free wall anchor repair kit; (b) a one-time, free installation of the kit at home if you do not know, do not want or are uncomfortable with the chest or the attachment of the chest of drawers to the wall; or (c) reimbursement of the purchase price of the chest or cabinet (not the retail price of units sold by IKEA). I received a label from my wall anchor kit indicating that the product has been recalled and instructing me to call toll free 866 number. What am I supposed to do with these? You must place the label in the top left drawer to remind you or any future user of the product that it should be attached to the wall. Do I need a receipt to participate in the recall? You don't usually need a receipt. However, we reserve the right to ask for a receipt based on the total number of crates and cabinets returned by the customer. are older IKEA chest or cabinets included in the recall? The KULLEN recall also included KULLEN 3 chests sold in U.S. stores and between April 2005 and December 2019. The June 2016 recall - Yes. We recall all crates and cabinets that we have ever sold in the US that do not meet the current ASTM F2057-14 standard. A list of recalled crates and dressers can be found below.
